

PRIVACY AND COOKIE STATEMENT

Artikel 1. Privacy

- 1.1. EverythingYouNeed has taken appropriate measures to secure your visit to and use of our website and to prevent abuse. All persons who may become aware of your data are obliged to maintain confidentiality thereof.
- 1.2. When you visit our website to obtain information, visitor data is collected and stored to promote the user-friendliness of the website. We use your data to process orders as quickly and easily as possible. When you place an order, we need your name, email address, address and payment details to process your order and to keep you informed of its progress.
- 1.3. To make your visit to and use of the website as pleasant as possible, we store your personal data and data about your order and the use of our services with your permission.
- 1.4. We use your email address to inform you about the development of the website and about special offers and promotions. If you no longer appreciate this, you can easily unsubscribe at the bottom of the mailing.
- 1.5. EverythingYouNeed will not sell your personal information to third parties and will only make it available to third parties that are involved in processing your order. Our employees and third parties engaged by us are obliged to respect the confidentiality of your information.

Artikel 2. Cookies

- 2.1. EverythingYouNeed uses cookies. Cookies are small text files that are placed on a PC, tablet, mobile or other device and that are read by a browser. When you visit our website again at a later time, the website checks whether there is a cookie on your computer. In this way we can recognize you on a next visit. You are not directly personally identifiable on the basis of the cookie.
- 2.2. In addition to the cookies placed by us, cookies can also be placed by third-party software. Think of cookies from Google Analytics or other suppliers. This software is used to analyze data traffic.

The cookies are used for the following purposes:

- remembering login names and passwords for efficient use of the website;
 - analyzing the use of the website;
 - collecting data relating to your browsing behaviour.
- 2.3. Cookies that remember your preferences can be disabled in your browser settings. You can set your browser so that no more cookies are placed on your computer. In that case, it is possible that not all services and

functionalities of the website will work properly. You will still see advertisements that will not be adapted to your preferences.
